2. To lease, purchase, hold, have, manage, use and take possession of and enjoy in fee simple, or otherwise, any personal or real property necessary for the uses and purposes of the corporation; to sell, lease, deed in trust, alien or dispose of the same at the pleasure of the corporation, and for the uses and purposes for which said corporation is formed; and to buy and sell real or personal property and to apply the proceeds of sale, including any and all income, to the uses and purposes of the corporation.

ARTICLE III

ARTICLE V

ARTICLE VI

That there shall be but one class of members, whose voting power, property rights and interests shall be equal.

ARTICLE VII

That the By-Laws of this corporation shall be adopted by the directors named in the Articles of Incorporation, and thereafter may be amended or repealed by any means provided in the By-Laws; and that any and all matters of corporate organization, procedure, government and management shall be as provided for in the By-Laws except as otherwise provided for in the Articles of Incorporation.
